OBJECTION. The Parish Council note that there appears to be an error with the location of the proposed new garage as it is shown to be on the property of Woodlands, not Two Oaks, and the proposal of a new garage in front of the property named Woodlands, to replace one that is to be demolished which is currently to the side of the property, is contrary to the Village Design Statement.

Location:        149 Winchester Road, Four Marks, GU34 5HY  
Proposal:        T21 Oak Tree, crown lift to 5m, prune back to leave 4m clearance from properties at 3 and 1a Goldcrest Way, crown thinning by 20%, no branches over 100mm diameter to be removed.  
All work to be limited to parts of canopy overhanging 3 and 1a Goldcrest Way.  
No Objection, and defer to the Arboriculturalist's decision.
  
7. Reference No: 36394/003                      Comment deadline: 21 October 2014  
Location:        Hawthorn Lodge, 14 Kingswood Rise, Four Marks GU34 5BD  
Proposal:        Fell one Oak tree  
Objection. The Parish Council do not wish to see the loss of the tree unless there is a valid reason for its removal, but defer to the Arboriculturalist's decision.
